

2012 Lowenstein Sandler Scholars Program for 1Ls

Lowenstein Sandler PC is committed to promoting diversity in the workplace, and to fulfilling the promise of a collegial and respectful working environment where each person is encouraged to reach his or her fullest potential. Furthering our on-going commitment to diversity, we are pleased to sponsor the **2012 Lowenstein Sandler Scholars Program**.

The 2012 LS Scholars Program will provide up to four law students with \$10,000 scholarships toward second-year tuition and paid Summer Associate positions with the firm upon completion of the first year of law school. The 1L summer positions will offer a salary of \$2,700/week or \$27,000 for ten weeks from May 21 to July 27, 2012 and will be located at either our New York or Roseland, New Jersey offices.

The scholarship may be renewed for the third year (3L tuition scholarship will be \$15,000) if the LS Scholar is offered and accepts a Summer Associate position with Lowenstein Sandler upon completion of the second year of law school, and maintains a minimum cumulative grade point average of 3.0 during his or her second and third years of law school.

Applicants for the 2012 Lowenstein Sandler Scholars Program must be currently enrolled full-time 1L students at Cardozo Law School, Columbia University School of Law, Cornell Law School, Duke University School of Law, Fordham University Law School, Georgetown University Law Center, Harvard Law School, NYU School of Law, Rutgers University School of Law-Newark, Seton Hall University School of Law, St. John's University School of Law, University of Pennsylvania Law School or Yale Law School, with a minimum cumulative grade point average of 3.0. The LS Scholar must spend a full ten-week summer at the firm.

To be considered, please submit the following application materials before February 3, 2012:

- Detailed cover letter presenting your career goals and reasons you should be a 2012 Lowenstein Sandler Scholar and a 2012 Summer Associate
- Current resume
- Undergraduate college and law school transcripts (*Unofficial versions are permitted and can be sent when available in February.*)
- Writing sample from first semester legal writing course (*Original student work product*)
- Personal essay (up to 500 words) describing your most significant challenge and how you met that challenge.
- Two references: Name and contact information for a law professor, legal writing instructor and/or previous employer.
