Hildebrand is featured in an article on **TVNewsCheck** spotlighting her presentation at the conference **Media Outlook 2020**, which expanded upon an article written by Hildebrand and **Carly S. Penner** for the Media Financial Management Association's magazine, **The Financial Manager**. Hildebrand explains how the United States differs from Europe and certain other countries in that it does not have a set of federal laws addressing privacy and cybersecurity generally and that federal laws here are industry-specific. Although the Federal Trade Commission is the de facto regulator of many online activities, including privacy and security standards, companies must now consider 50 different state data breach laws, plus Guam, Puerto Rico, and the Virgin Islands. California and Nevada have also adopted comprehensive data protection laws, and more states are considering similar legislation.
