If LS Scholars are offered and accept Summer Associate positions with Lowenstein for their 2L summer and they remain in good standing during their 2L academic year, they will receive up to a \$15,000 scholarship for 3L tuition and related fees after successful completion of the 2L Summer Associate Program in 2027.

  - Please submit a cover sheet with your writing sample. In the cover sheet, please: (a) explain the assignment that generated the sample; (b) explain what sections, if any, you omitted from the sample to meet the 15-page limit; and (c) identify any persons who assisted you in drafting it.
