We counsel clients on permitting and regulatory issues and environmental audits. We have successfully tried or otherwise resolved a wide range of environmental litigation, including cost-recovery claims, cancer-cluster toxic tort cases, and permit challenges. We also serve as common counsel and hold leadership roles in a number of complex site remediation matters.

- > In connection with corporate and real estate transactions, advises clients ranging from large corporations to small family-owned businesses on compliance with New Jersey environmental law, including the Industrial Site Recovery Act.
