The plaintiff in the case claimed to be totally disabled due to internal head injuries resulting from an accident which occurred on property managed by Aramark. The claim was bifurcated into two phases: liability and damages. The jury determined that Aramark was not liable and therefore prevented the second phase.
- > Serve as co-counsel for Prudential Financial in the trial of many consolidated employment cases.
- > Successfully represented Aramark Corporation on appeal of a \$135 million judgment, which was vacated. Currently serving as national dram shop trial counsel for Aramark Corporation and its subsidiaries.

The case resulted in a defense verdict on all claims.
